

Apex United Methodist Church Memorial Garden
Contract for Inclusion of Name(s) on Memorial Wall (Rev. 12/19/23)

This contract made and entered into this _____ day of _____, _____, by and between Apex United Methodist Church ("AUMC") and _____ ("Purchaser").

WHEREAS, AUMC has designated a plot of land on its premises known as the Apex United Methodist Church Memorial Garden, which contains a memorial wall for the inclusion of names of eligible persons; and

WHEREAS, AUMC has established an Apex UMC Memorial Garden Columbarium Guidelines & Sales Agreement ("Policy"), the document attached hereto and made a part hereof, governing eligibility and use of the Apex United Methodist Church Memorial Garden memorial wall;

THEREFORE, the parties hereby agree as follows:

1. AUMC agrees to provide Purchaser and Purchaser agrees to pay for the inclusion of a name or names on a memorial wall faceplate.
2. AUMC agrees to have the faceplate inscribed with the name(s) of the person(s) to be identified and to provide perpetual care.
3. Purchaser has read the Policy, is familiar with the contents thereof, and agrees to be bound by the Policy.
4. Purchaser authorizes AUMC to relocate the Memorial Garden, including the memorial wall and its faceplates, to another location should it become necessary for any reason, and this authorization shall be binding upon heirs, executors, administrators, and assigns.
5. Purchaser warrants that he/she has all rights to execute this contract. AUMC has and assumes no responsibility to inquire further into the authority of the persons executing this contract.
6. Purchaser provides the following information to be inscribed on the memorial faceplate(s) to include no more than 35 characters per name:
